

# ARTWORKS TOGETHER

## Submission Terms and Conditions

### Rules of Entry

- Entry to Artworks Together is open exclusively to individuals with Learning Disabilities and/or Autism.
- Learning disabilities and Autism must be accurately classified/described as a part of the application form for the submission to be considered.
- Anyone considered to have a Learning Disability and/or Autism is eligible to enter.
- You must be over the age of 16 to submit your work.
- For an application to be considered, all required fields of the application form must be completed.
- The applicant must have read, understood and accepted the Terms and Conditions in order to submit their application. In the event of the application being unable to read/accept the Terms and Conditions themselves, a parent or guardian must do so on their behalf. This chosen parent/guardian must be readily present and contactable during the selection process.
- For those who may be unable to access the internet personally, we ask for you to find someone that can apply for you on your behalf.
- The applicant must be the legal copyright holder of the work submitted. It is the responsibility of the artist to ensure that the work is not restricted under any copyright law.
- Group entries are welcome. Ensure that the names and individuals contributions are described in the application form. In the event of such an application, one member of the group must be labelled as the "primary artist" and act as representative for the full group.
- The art work can be about anything you choose.
- Please only submit one piece of art work per person.
- Groups or collectives can enter up to 5 pieces of work.
- Once submitted, the submission cannot be edited in any way.

### Entry Format

- Ensure that you include a high-resolution digital capture of your artwork within your application.
- Applications are not strictly limited to one file attachment of artwork. If you feel that it would help to convey your artwork within your applications, you may include up to five attachments of varying file formats. *Eg. a single sculpture may be primarily submitted as a scanned 3D file, accompanied by individual image files.*

- However, the number of files submitted is left entirely to the decision of the applicant. -  
Preferred file types:

**Images:** PNG, TIFF

**Video:** MP4, MOV

**Audio:** MP3, WAV

- Accepted forms of art are: Pencil, Acrylic, Water Colour, Oil Painting, Paper Art, Woodblock Print, Calligraphy, Embroidery, sculpture, film, photography, etc.

- It is the responsibility of the applicant to ensure that all photos/videos/scans/audio files are of high quality and that the content of the work is legible.

- In the event that the content of the work is not legible due to scanning errors, an uneven image or not able to be verified, the entry will not be considered.

- Film submissions are accepted. Film submissions must be under five minutes in length, excluding any end credits.

### **Points of Caution**

- Submissions are only accepted via the Artworks Together website via the form on the *submit* page. Entries outside of this designated system will not be considered. Entries sent in error will be destroyed.

- Applications that do not adhere to the specified guidelines, or rules for entry will not be considered.

- Only submit art for which the artist or artist's representative can claim full copyright for.

- By submitting your work to Artworks Together you agree that if your work is selected for inclusion in our exhibition, we have full permission to exhibit the work as a part of our exhibitions in perpetuity. If for any reason you do not want your work included after submitting, you must inform us within 5 working days of the final submission deadline. Confirmation must be granted by the organisers in order for work to be officially withdrawn.

- If a piece of work is submitted accompanied with an incomplete submission form, the application will not be considered. It is the responsibility of the applicant to ensure their application is completed in full. Artworks Together is not strictly responsible for contacting applicants regarding incomplete applications.

- In regards to the winners of ArtWorks Together, the entries may be subject to sale, or reproduction. This may result in change or modification of the work. In the case of sale, proceeds via royalties will be paid to the artist with a commission rate of 40% of the sale to ArtWorks Together. For this reason, the artwork would not be returnable.

- By submitting, the applicant grants full permission for Artworks South Yorkshire to use the work for the purpose of advertising and promotion for Artworks Together, regardless of the final outcome of the judging process.

- Enquiries regarding the timescale or the expected outcome of the judging process will not be answered.
